New Structures & Additions	\$0.12 per square foot, plus \$125 (Minimum \$400)

Remodels	\$6.00 per thousand (construction cost)
Early Start Permit (Footings & Foundation Only)	\$0.02 per square foot or \$100.00 (whichever is greater)

Plumbing, Electrical, or HVAC	\$0.04 per square foot
Electrical Service	\$100.00
DEMOLITION:	
Residential Dwelling	\$50.00
Accessory Structure	\$25.00

PROPERTY MAINTENANCE:	
Property Maintenance & Special Inspections	\$65 per hour

No permits are required for re-roofs, replacement windows, and siding.
